

COLSC By-Laws

1. Membership includes you, your spouse, children under 18 living in your household, and dependent children over 18 attending college or vocational school.
2. Members must sign in at the Kiosk when entering the club and sign out when leaving.
3. Members may access the COLSC property and use the pistol and rifle ranges at any time. Eye and ear protection is required.
4. Members may bring a guest twice for the use of rifle and pistol facilities. After that, they must join. Guest fee is \$5.00 and guest must sign a Release Form. Release forms are at Sign-in Kiosk. Place \$5. and the form in lockbox.
5. Guests pay the non-member rate for USPSA.
6. Non-members unaccompanied by a member pay the non-member rate for skeet and trap.
7. **Please keep the gate closed and locked while you are at the club when the club is not open to the public.**
8. Please do not allow children to climb the sand berms in the Cowboy & USPSA pistol areas. This reduces the height of the berms, making them less safe and in need of repair.
9. When a Cowboy Action Shoot or a USPSA Shoot is in progress, the pistol bay closest to the Storage trailer may be used, but not the other stages set up for the shoot.
10. Please do not re-arrange or shoot at, the USPSA and CAS target after they have been setup and painted for an upcoming shooting event.
11. Do not use jacketed or high-powered ammunition on the steel targets. Cast lead ammo only on these targets.
12. Rifle shooters may not use the 200-yard range unless approved by a Range Officer. No caliber below .204 Ruger on the 200-yard Range.
13. Range Safety Officers to contact for 200-yard range approval: Al Moran @ 231-676-0957 or Bill Clark @ 888-875-5769.
14. The 200-yard range is not to be used when a USPSA shoot is in progress.
15. Please remove your paper targets from the range when you are done shooting and clean up your empty brass.
16. During rifle sight-in days, members do not pay the per-gun sight-in fee.
17. Members may not hunt on COLSC property, only the Founders.
18. Skeet and trap are available only on designated shooting days, under supervision of a member of the Clays Committee, unless prior permission is obtained. Pick up all spent shotgun shells from shotgun ranges.
19. **USE COMMON SENSE. OBSERVE ALL SAFETY PROCEDURES IN HANDLING FIREARMS. CLEAN UP AFTER YOURSELF, ENJOY THE PREMISES, AND GET INVOLVED.**
20. **USE/POSSESSION OF ALCOHOL/DRUGS PROHIBITED**
21. Remove all trash, spent shotgun shells, etc. from the premises.

Definitions: Founder is a person who has purchased the land that the Club is using.

Founder/Shareholder is a person who has property right but is not a Founder with voting rights.
